

**MEMORANDUM OF
UNDERSTANDING
BETWEEN
THE CIVIL AVIATION
AUTHORITIES OF THE RUSSIAN
FEDERATION
AND
KINGDOM OF BAHRAIN**

Delegations representing the Civil Aviation Authorities of the Russian Federation and the Kingdom of Bahrain met on the 5th December, 2023 in Riyadh during ICAO Air Services Negotiation Event (ICAN2023) to discuss bilateral relations in the field of civil aviation based on the Air Services Agreement signed on June 17, 1994 between the two countries.

The list of the delegations is attached as Appendix A.

Both delegations expressed desire to advance their aviation relationship in a spirit of cooperation for their mutual benefits.

The following understandings were reached:

1. Traffic Rights

The designated airline(s) of both Contracting Parties are allowed to operate up to 14 weekly flights on the route Moscow – Manama and an additional 7 weekly frequencies on each city pair for passengers or in combination flights (passenger and cargo) with 3rd and 4th freedom traffic rights without any restriction on aircraft type.

The designated airline(s) of both Contracting Parties are allowed to operate up to 14 weekly frequencies on each city pair for all-cargo flights with 3rd and 4th freedom traffic rights without any restriction on aircraft type.

2. Airline designation

The delegations agreed to lift the restrictions on the number of designated air carriers established by the Memorandum of Understanding between the Aeronautical authorities of the Russian Federation and the Kingdom of Bahrain dated April 29, 2014.



3. Implementation

The provisions of this Memorandum of Understanding shall come into effect on the date of its signature and will supplement MOU, signed 29th April, 2014.

Done on 5th December, 2023, in Riyadh, Saudi Arabia.
