The Directorate of Air Transport of the kingdom of Morocco presents its compliments to the aeronautical authorities of Russian Federation and wishes to refer to the long standing and excellent relations that exist between our countries.

This is an opportunity to confirm the interest and will of the aeronautical authorities of Morocco to further reinforce cooperative relations in civil aviation field between Morocco and Russia.

In this regard, I have the honour to inform you that our national company Royal Air Maroc will operate its new structure via Munich as an intermediate point without traffic rights starting from the 19th of May, 2015 by combining the two routes of Casablanca - Moscow v.v and Casablanca - Munich v.v with Embraer (see schedule details in the attached document).

Accordingly, I would like to assure you that the Moroccan Party will reciprocally grant any intermediate point requested by Russia airlines as provided in the Memorandum of Understanding signed and the Air Services Agreement initialled on the 26th of November, 2010.

By reiterating our disposal to work towards strengthening cooperation ties in all fields of civil aviation for the benefit of both countries, I beg you to believe, Dear Sir, the assurance of my highest consideration.
