Уважаемый Владимир Владимирович!

Направляю Вам копию письма Генерального секретаря Международной организации гражданской авиации (ИКАО) г-на Хуана Карлоса Саласара № ТС 2/3.38 (12/801) – 24/18 от 13 февраля 2024 года, информирующего о запуске стипендиальной совместной учебной программы Республики Корея и ИКАО по подготовке кадров для развивающихся стран в 2024 году.

Согласно представленной Секретариатом ИКАО информации на сегодняшний день Правительством Республики Корея субсидируются 11 учебных курсов по программе подготовки высококвалифицированных специалистов гражданской авиации для развивающихся стран, охватывающих, в частности, следующие области подготовки: (i) безопасность полетов; (ii) аэронавигация.

Подробная информация о порядке и условиях предоставления будущих стипендий, грантов, содержания учебных программ приводится в дополнениях А, В и D к письму Генерального секретаря от 13 февраля 2024 года.

Дополнительно сообщаем, что Представительством Российской Федерацией при ИКАО был направлен запрос в адрес Управления ИКАО по вопросам наращивания потенциала и внедрения, где подтвердили, что Российская Федерация входит в число стран, которые могут выдвигать кандидатов для участия в указанной стипендиальной программе для развивающихся стран.

С учетом вышеизложенного прошу Вас дать поручение Росавиации довести информацию, содержащуюся в настоящем письме, до сведения соответствующих

отраслевых учебных заведений и организаций на предмет участия российских профильных специалистов в предлагаемых курсах.

Имею честь обратить внимание на разработанную совместно Республикой Корея и Международной организацией гражданской авиации (ИКАО) программу по подготовке кадров для развивающихся стран, спонсором которой является Управление гражданской авиации Министерства земель, инфраструктуры и транспорта (MOLIT), а административную поддержку обеспечивает ИКАО. Начиная с 2001 года 3167 участника из более 136 стран успешно прошли программу подготовки, включая учебные сессии на местах, проведенные в Африке и Латинской Америке.

С удовлетворением сообщаю, что в этом году подготовка в рамках 11 курсов на базе указанной программы будет предложена 180 участникам из развивающихся стран. Информация о предлагаемых курсах, а также порядке и условиях получения стипендий приводится в дополнениях А–D. Однако важно иметь в виду, что вопросы, связанные с содержанием и порядком проведения курсов, которые не проводятся непосредственно ИКАО, не входят в компетенцию Организации, и, следовательно, полную ответственность за них несет MOLIT. Заявителям необходимо заполнить онлайн-форму заявления на сайте [www.korea-ftp.org](http://www.korea-ftp.org). Просьба иметь в виду, что представившие заявления государства будут проинформированы о результатах процесса отбора не позднее, чем за три недели до начала курса.

## The 2024 Republic of Korea – ICAO Training Programme for Aviation Personnel

### 1. Overview

The Republic of Korea (ROK) has launched the Training Programme to contribute to the evolution and safety of the world's aviation industry since 2001. In 2006, ROK and ICAO, recognizing the importance of assistance and cooperation in the aviation training, established the training programme which is sponsored by the Government of the ROK and administered by the ICAO Technical Cooperation Bureau, and conducted by the Civil Aviation Training Centre (CATC) of Korea Airports Corporation and Incheon Airport Aviation Academy (IAAA) of Incheon International Airports Corporation.

In accordance with this MOU, the ROK will invite 180 trainees from the ICAO Member States and deliver the courses as below in 2024.

**3. Training institutes**

**a) CATC**

The Civil Aviation Training Centre (CATC) of Korea Airports Corporation was established in 1984 with United Nations Development Programme (UNDP) and ICAO aids for improvement of technical expertise to contribute to the safety and development of the civil aviation industry. KCATC offers specialized training courses for domestic and international trainees in an effort to foster global-minded human resources experts in the air navigation system, airport management and operation, air traffic control and other fields in the aviation industry. Furthermore, CATC was certificated as a TRAINAIR PLUS Regional Training Centre of Excellence on 2015.

CATC is staffed with excellent instructors and equipped with state of the art, practical training facilities. Trainees will be staying in CATC dormitory and will have access to its amenities

<p>Training Facilities and Equipment</p>	<p>Ten lecture rooms and two seminar rooms are fully equipped with audio-visual aids such as beam projectors and video presentation aids.</p> <p><b>(Intl' building)</b> Training equipment and electronic calibrators are provided for every course to allow practical training: DVOR/DME, ILS, radar simulator, U/VHF telecommunication equipment, GPS training equipment, network training equipment, and over 30 test equipment including oscilloscopes and spectrum analyzers.</p>
<p>Dormitory</p>	<p>Trainees will stay in dormitory (one room per person) equipped with air conditioning and heating, and served with meals that different nationalities can enjoy. Gym, movie theater, and karaoke are also available for the trainees' use.</p>



**b) IAAA**

Incheon Airport Aviation Academy (IAAA) has been selected as an ICAO Regional Training Center of Excellence on 11 September 2014. IAAA is authorized to develop and deliver ICAO Training Packages in the following areas: Aerodromes, Air Navigation, Flight Safety, and Safety Management. Additionally, as a TRAINAIR PLUS Member, IAAA has been delivering several TRAINAIR PLUS Standardized Training Packages (STPs) and ICAO Training Packages (ITPs) for domestic and international trainees. In addition, IAAA has been designated as the ACI GTH (Global Training Hub) in the Asia-Pacific Region by an agreement reached between Incheon Airport in 2007 and became the ACI ATP (Accredited Training Partner) since 2023. Finally, IAAA was designated as the ITC (IATA Training Centre) in 2017 and was certified as the RTP (Regional Training Partner) by IATA on October 2023.

IAAA has been offering practical training courses which are relevant and applicable to the various aviation fields. The main content of courses consists of not only theoretical lectures but also practical training such as experience of airport operation, on-site visits and workshops for problem solving.

Training Facilities and Equipment	26 different sized classrooms including banquet hall and auditorium, 5 group workrooms, multi-media computer lab, on-line lecture room, ATC(Apron Traffic Control) simulator, and AVSEC(Aviation Security) training lab equipped with Walk-through Metal Detector, Security Scanner, and Tray Return System.
Dormitory	There are 102 hotel-style guest rooms (VIP, single, and double rooms) fully furnished with air conditioning/heating, LCD TVs, and internet access. For recreation, football field, jogging track, tennis court, basketball court, pool table, table tennis, fitness center, and sauna available free of charge. In addition, there is also a business center with internet access, fax, photocopy machine, and magazines.



**c) Training contents**

Courses consist of classroom lectures, practical training, and on-site visits. In particular, trainees will meet with senior officials for aviation safety and air navigation system, and discuss cooperation.

Trainees will also have opportunities to visit Incheon Airport, Gimpo Airport, air traffic control facilities, the aviation museum, and other important aviation facilities, in addition to experiencing Korean culture on a visit to historical palaces and other popular tourist spots.

All trainees should complete Attachment C Participant’s Itinerary for airport escort service and send it to the training institute as you are guided after being selected at least 14 days before the training start date. More information of accommodation and transportation will be provided by the training institute 3 weeks before start of the training.
