Dear Mr Belavintsev,

The French General Directorate for Civil Aviation presents its compliments to the Department of State policy in Civil Aviation of the Ministry of Transport of the Russian Federation, and would like to refer to your letter dated 30 September 2020 (Nr. 9-906) in which you request to reallocate the quota for Russian designated airlines on the Kaliningrad – Paris route (7 weekly frequencies), on the Samara – Paris route, on a temporary basis. First of all, let me thank you for your confirmation that our bilateral agreement remains at the heart of air services between France and Russia.

During the last bilateral consultations which took place in Paris on 4 and 5 October 2018, the French Aeronautical Authorities agreed to increase the maximum number of weekly frequencies to be operated between our two countries per flag from ninety-eight (98) to one hundred thirty-nine (139) frequencies, in total, on all the routes, and split into several envelopes.

Over IATA Winter Season 2020-2021, the Russian designated airlines submitted a total of eighty-one (81) weekly frequencies to be operated.

Hence, even if some of the remaining frequencies are dedicated to specific routes and airlines, a large number of frequencies are still available in the general envelope (outside the dedicated ones) and could, without any change to our bilateral framework, allow a Russian airline to operate seven (7) weekly frequencies between Samara and Paris.

As a consequence, in consistence with Mr Lamalle's letter dated 5 June 2019 (Nr. 19-079) addressed to Mrs Svetlana Petrova, I consider that such temporary reallocation is unnecessary. In order to proceed quickly, I have the honor to inform you that, from the date of the diplomatic designation of a Russian airline, I am prepared to authorize it to operate an adequate number of frequencies between Samara and Paris. I will be glad to confirm this interpretation from IATA Summer Season 2021 subject to the full set of Russian airlines' schedules.
