MEMORANDUM OF UNDERSTANDING BETWEEN THE AERONAUTICAL AUTHORITIES OF THE RUSSIAN FEDERATION AND THE KINGDOM OF SPAIN

Delegations representing the Aeronautical Authorities of the Kingdom of Spain and the Russian Federation (hereinafter referred to as the Spanish Delegation, the Russian Delegation or both Delegations respectively) met in Colombo on 6th December 2017 to discuss air transport matters of mutual interest.

List of Delegations is attached hereto as <u>Appendix I</u>. The head of the Spanish delegation was duly entitled by articles 6.1.e) and 6.2.a) of Royal Decree 362/2017.

- 1. The discussions were held in a friendly and constructive atmosphere. Both sides discussed the following issues:
- 2. Both Delegations agreed to grant to the designated airlines of the Russian Federation the right to coterminalise Barcelona and Tenerife.
- 3. Both Delegations agreed to add Castellon de la Plana as point of destination in the territory of the Kingdom of Spain for the designated airlines of the Russian Federation in the Annex of Air Services Agreement in force.
- 4. Both Delegations confirmed that to the routes from the points of the Russian Federation Castellon de la Plana the provisions of the Part II (Designation of airlines and frequencies) of the Memorandum of Understanding between the Aeronautical Authorities of the Russian Federation and the Kingdom of Spain dated February 26, 2016 will be applicable.



7. This Memorandum of Understanding will come into effect on the date of signature.
