Dear Dr. Nowier,

The Department of State Policy in Civil Aviation of the Ministry of Transport of the Russian Federation presents its compliments to the Civil Aviation Authority of the Arab Republic of Egypt and has the honor to address as follows.

In addition to the letter dated December 14, 2018 Num. 9-1752, as well as in continuation of the agreements reached during the meeting of the Ambassador Extraordinary and Plenipotentiary of the Arab Republic of Egypt to the Russian Federation Mr. Ihab Nasr and the representatives of the Ministry of Transport of the Russian Federation, we confirm the readiness of the Russian side to amend paragraph 3 of the point 1 of the Memorandum of Understanding dated March 3, 2009 as follows:

“The designated airline(s) of each of Side shall be entitled to operate 3 (three) all-cargo scheduled services per week in total on the specified routes with any aircraft type”.

If the abovementioned proposal is acceptable for the Egyptian side, we suggest this letter and your positive response to it to be considered as an agreement between the Aeronautical Authorities of Russia and Egypt.
