
Aeronautical Authorities of the Russian Federation present its compliments to the Hellenic Civil Aviation Authority and you personally and wish to refer to your letter ref. no CAA/GOV/1376.

According to point 4 of the MOU between Aeronautical Authorities of the Russian Federation and the Hellenic Republic from April 24th 2012, Greek airlines for the period between May 15th 2012 and the end of IATA Summer Season 2012 will be entitled to operate scheduled flights from **one point in Greece** to Novosibirsk, Omsk, Perm, Nizhniy Novgorod, Tyumen, Ufa, Samara and Volgograd with one frequency per week.

As stated in your letter from May 10th ref no. CAA/GOV/1376 point Thessaloniki was assigned by the Hellenic side as a point of departure for operating the abovementioned flights.

In regard to your letter ref no. CAA/GOV/1376 Russian side is ready to grant a permission for operating flights from **Thessaloniki to points Novosibirsk, Omsk, Perm, Nizhniy Novgorod, Tyumen, Ufa, Samara, Volgograd, Voronezh and Saratov, except flights between Thessaloniki and Yekaterinburg**, with one frequency per week.
